### PARENT AND COACHES CODE OF CONDUCT

The Hickory-Fountain Green Girls Fastpitch Softball program strives to provide a positive experience for our girls. Our number one goal is for the girls to learn about good sportsmanship, learn to play softball all while making new friends and having FUN!

Therefore by reading and signing this form and the registration form for your daughter/relative, you will agree to abide by the rules within this Code of Conduct policy set forth by our program and the Hickory-Fountain Green Recreation Council Board of Directors.

#### AT ALL TIMES:

- Coaches/parents/spectators agree to demonstrate positive behavior towards all players, umpires/officials, opposing coaches/parents/spectators or any others in attendance.
- Adults are expected to encourage the players and teach them good sportsmanship by: refraining from the use of offensive language and comments; no taunting including negative cheers, making distracting noises, comments or gestures to distract players; no physical altercations; no arguing with the umpires about calls including balls and strikes.
- Adults will provide a safe environment by taking precautions and being aware of the activity of players during the game both on and off the field, including safety around the bench area and on-deck batters circle (one batter at a time and no swinging bats behind the bench).
- Adults will put the well-being of youth ahead of the personal desire to win "at all costs". It is expected that during the end-of-season tournament, coaches/adults will continue to exhibit similar positive behavior and maintain a positive experience for all.

By reading this side of the form and signing the registration form, I pledge to be responsible with my words and actions while participating in any youth sporting event sponsored by or involving the Hickory-Fountain Green Softball program, including participation in events involving other rec council's softball programs, as well as any other HFG Recreation Council youth program.

Failure to abide by these rules will result in disciplinary action being taken, including but not limited to the following:

- The offender will be asked to leave the field immediately by the umpire or program official present;
